

MINUTES

REGULAR MEETING OF MAYOR AND COUNCIL OF JUNE 4, 2012

Call to Order: The regular Meeting of Mayor and Council of June 4, 2012 was called to order by Mayor Pro-tem Sparkle Adams at 6:30 p.m.

Invocation: The invocation was given by Rev. Leon Beeler followed by the Pledge of Allegiance to the American Flag.

Roll Call: Mayor Pro-tem Sparkle Adams and Councilwomen Maudie McCord, Latresa Akins and Linda Lord.

Approval of Minutes: Ms. McCord made a motion to approve the following minutes, seconded by Ms. Akins.

Ms. Akins made a motion to close the Public Hearing and reconvene the meeting, seconded by Ms. McCord. Voting for the motion was unanimous.

**Ordinance:
Budget:** Request was made to consider an Ordinance by the Governing Body of the City of Forest Park, Georgia, establishing the Budget for the Fiscal Year 2012-2013.

Ms. Lord made a motion to approve the Ordinance, seconded by Ms. Akins. Voting for the motion was unanimous.

**Resolution -
Southern
Football League:** Request was made to consider a Resolution by the City Council of the City of Forest Park authorizing the Mayor to execute a License Agreement with the Southern Football League for the use of Kiwanis Stadium to conduct a Football Game at a rate of two hundred dollars (\$200) per game for the stadium and seventy-five dollars (\$75) per game for use of concession stand; to provide for severability; to provide an effective date; and for other purposes.

Ms. Akins made a motion to approve the Resolution, seconded by Ms. McCord. Voting for the motion was unanimous.
