Laws 4409 Et Seq., as amended, so as to annex certain land into the Corporate Limits of the City; to repeal all Ordinances and Charter provisions in conflict herewith; to provide an effective date; and for other purposes

SUMMARY AND BACKGROUND: An appropriation is requested in the amount of \$44,200.00 to cover telephone and internet services costs. These funds are needed to cover the upgrade of communications lines to fiber optic cable for all City Departments.

9. Consider an Ordinance by the City Council for the city of Forest Park, Georgia, to appropriate additional funds in the total amount of \$103,410.00 to cover vehicle insurance costs and property and liability insurance costs for several City Departments; to repeal all Ordinances and parts of Ordinances in conflict herewith; to provide an effective date; and for other purposes

SUMMARY AND BACKGROUND: An appropriation is requested in the amount of \$103,410.00 to cover vehicle insurance costs, and property and liability insurance costs. These funds are needed due to increased insurance rates and

also as the result of addition of city vehicles and property purchased.

Consider an Ordinance by the City Council for the City of Forest Park, Georgia, to amend Title 11, Chapter 2 of the Code of Ordinances, so as to provide that it shall be unlawful to appear in a public place in the City wearing pants or skirts more than three (3) inches below the top of the hips (i.e., the crest of the Ilium) exposing the skin or undergarments; to provide that persons who violate this ordinance shall be subject to certain fines, but shall not be subject to arrest or imprisonment; to repeal all Ordinances and parts of Ordinances in conflict herewith; to provide an effective date; and for other purposes
