REGULAR MEETING OF MAYOR AND COUNCIL OF MARCH 20, 2017

Call to Order: The Regular Meeting of Mayor and Council of March 20, 2017, called to order by Mayor Pro-tem Dabouze Antoine at 6:10 p.m.

Invocation: The invocation was given by Pastor Chaz Afzal, The Life Church, followed by the Pledge of Allegiance to the American Flag.

Roll Call: Mayor Pro-tem Dabouze Antoine, Councilmembers, Tommy Smith, Sandra Bagley, Latresa Wells and Allan Mears.

Also present were Chief Dwayne Hobbs, Interim City Manager; Mike Blandenburg, Director Finance; Jonathan Jones, Director PB & Z; Jeff Eady, Director Public Works; Angela Redding, Management Analyst; Christine Terrell, Director Support Services; Chief Eddie Buckholts, Fire; and City Attorney, Winston Denmark.

Comment Period: None

Approval of Minutes: Councilwoman Bagley made a motion to accept and approve the minutes together of March 6, 2017, Councilman Smith seconded the motion. Voting was unanimous.

Ordinance: Ordinance to amend Section 11-3-8 (“Pens or Enclosures Pens/Enclosures within 400 feet of house or building”) in Chapter 3 (“Animals”) of Title 11 (“Offenses”) in the Code of Ordinances, City of Forest Park, Georgia.

Mr. Jones discussed the ordinance. Councilwoman Wells made a motion to accept the ordinance. Councilman Smith seconded. Voting was unanimous.

Resolution: Resolution by the Mayor and Council of the City of Moratorium Forest Park, Georgia establishing a one hundred eighty-three Religious (183) day moratorium on the enforcement of the assembly Institutions use provisions of the zoning code with respect to religious institutions and/or places of worship.

Mr. Jones discussed the resolution. Councilman Smith made a motion to accept this resolution. Councilwoman Wells seconded. Voting was unanimous.

Ordinance: Ordinance to amend the Code of Ordinances, City of Forest
Department Park, Georgia, to establish a Department of Technology
Technology Services by amending Subsection A of Section 2-3-1
Services (Departments Established) in Article A (General Provisions)
of Chapter 3 (Administration) in Title 2 (General
Government) and by enacting Title 12 (Technology Services)
and Chapter 1 (Department of Technology Services) in said
Title.

Councilwoman Bagley made a motion to establish the Department of Technology Services. Councilman Smith seconded. Voting was unanimous.
