Purpose:

The City of Forest Park is renovating the Outdoor Pool located in Starr Park at the corner of Park Place and Hines Ward Pass. Forest Park Public Works will support the Recreation & Leisure Department in the renovation and construction process. The pool is located at 5031 Park Avenue, Forest Park Ga. 30297. The purpose of this RFP is to seek proposals from general contractors for the construction and renovation work on the outdoor pool and to bring the pool up to current code and to improve the overall environment for the users. .

Scope:

The general contractor will furnish a proposal price for all materials, labor and equipment to re-plaster the pool surface, repair / replace the expansion joints, replace the water line tile, install a new pump, install a new VFD, chlorine feed system, automated controller, repair the pool deck and replace the filter.

The work will be completed during normal business hours but weekend work is allowed. The pool is located near a residential area therefore hours of construction will be regulated. The contractor must familiarize himself with the all details of the work required and existing conditions.

The contractor must be an ongoing entity for at least 5 years, produce a valid certificate of liability insurance, which must be on hand before work begins. All work will be permitted and inspected through the Forest Park Planning Building and Zoning Department and is the responsibility of the contractor.

The City of Forest Park will hereinafter be referred to as the "City." Respondents to the RFP shall be referred to as "Bidders." The Bidder to whom the contract is awarded shall be referred to as the "Contractor."

General Requirements:

REPLASTER:

Draining the pool by Forest Park Staff- Company to completely drain Remove any plaster material down to the original gunite

Saw cut out any cracks in the pool and apply an epoxy material.

Scarify the pool surface and prep for adhesive

Apply Kover Krete Pre-Kote System. This product must ensure a bond between the old and new plaster. The product also strengthens the new plaster.

Saw cut under and around gutter, main drains, returns, skimmers, etc.

Apply Diamond Brite quartz plaster mix (minimum 3/8" thick) and trowel to a smooth finish.

Company to provide written instruction on proper water chemistry to ensure proper curing of the new plaster.

Forest Park Staff will be responsible for brushing pool for approximately $2\,$

- 3 weeks to ensure proper curing of new plaster.

Warranty includes cracking, peeling or delaminating plaster. DOES NOT include chemical damage piaster.

Replace any damaged floor returns.

Replace main drain frames and grates with VGB approved

Warranty 3-years

EXPANSION JOINTS

Remove existing backer rod and caulk material Prep the expansion joints and main drains

Install new backer rod

Caulk with self-leveling caulk on floors and standard caulk on walls

WATER LINE TILE

Remove existing water line tile
Prepare existing surface to a smooth finish
Install new 6 X 6 water line tile-standard color chosen by Forest Park
Grout in new tile

PUMP

Remove the existing Cast iron pump and strainer Install a new Pentair EQ 10 hp pump with strainer. Provide any pipe modifications needed Pump will be 3 phase TEFC

Install a new Fiberglass PVC Concentric increaser on pump discharge. Install a new 6" PVC valve and flanges on pump discharge

VFD

Install a new ABB Variable Frequency Drive Model # ACH 550, wall mounted, 480V, 3-phase, NEMA 1 enclosure, electronic by pass IO hp Electrical included motor starter if needed to new pump

CHLORINE FEED SYSTEM

Remove the existing Pulsar chlorine Feed system Install a new Pulsar P 140 chlorine feed system with PLC panel Install new Venturi feed line with new 1-1/2" PVC piping

AUTOMATED CONTROLLER

Remove the existing automated controller Install a New Prominent DCM 200 automated controller Install a standard router Calibrate and standardize

POOL DECK

Sand blast and remove down to bare concrete Saw cut and epoxy cracks, option to create design with saw cuts Spray on texture deck Stain to color choice by Forest Park

Qualifications:

All bidders must be licensed, qualified, and understand how to identify the most effective and efficient construction methods to complete the project.

Communication:

It is the responsibility of the bidder to inquire about any requirement of this RFP that is not understood. Responses to inquiries, if they change or clarify the RFP in a substantial manner, will be forwarded by addenda to all parties that attended the pre-proposal meeting. The City will not be bound by oral responses to inquiries or written responses other than addenda. Inquiries about the RFP must be made to:

The deadline for all inquiries is April 1, 2019 at noon.

Evaluation:

Award will be made to the bidder considered most qualified who will act in the best interest of the City and whose proposal meets the demands of the City's services. Bid packages must include at least three (3) references. These references should be of a similar project and should represent agencies utilizing the bidder's services as outlined in the proposal. Bidder to provide company names with contact person and telephone number.

Evaluation Criteria:

Proposals will be evaluated on many criteria deemed to be in the City's best interests to include but are not be limited to:

- Ability to meet specifications
- Pricing
- Responsiveness to proposal terms and conditions
- References
- Quality of good and services
- Workmanship and material warranty
- Experience in providing the services specified in this RFP.

Pre-proposal:

There is a mandatory pre-proposal conference that will allow for a detailed discussion of the staff and use patterns, our services and the City's expectations. At this time, bidders will have an opportunity to address any questions, and communicate the feasibility of the City's expectations. If bidders do not attend this conference and still submit a bid package, their bids will not be considered valid and will not be considered for award.

The pre proposal conference will be held on March 20, 2019 and begin promptly 10:00 am at Forest Park Public Works Department, 5230 Jones Road, Forest Park Georgia, 30297.

Award:

The City reserves the right to conduct any tests it may deem advisable and to make all evaluations. The City reserves the right to reject any or all bids, in whole or in part and is not necessarily bound to accept the lowest bid but instead will accept the bid that is lowest, most responsible, most responsive and best suites the City and the City's services. The City reserves the right to waive minor irregularities. A bid may be rejected if it is in any way incomplete or irregular. When there are tie bids, there shall be a preference for local.

It is the responsibility of the bidder to inquire about any details of this RFP that are not understood. All inquiries must be submitted by email. Responses to inquiries, if they change the RFP in a substantial manner, will be forwarded by email addenda to all parties that attended the pre-proposal meeting. Therefore, it is the responsibility of the bidder to ensure an email address has been provided.

Submission: A SIGNED original and three (3) copies of the bid must be received at Forest Park City Hall, 745 Forest Parkway, 30297. Deadline for submittals is April 5, **2019** at 2pm. The bid must be date/time stamped by Forest Park City Hall in order to be considered. Bidders are strongly encouraged to submit bids in advance of the due date/time to avoid the possibility of missing the deadline due to unforeseen circumstances. Bidders assume the risk of the methods of dispatch chosen. The City assumes no responsibility for delays caused by any package or mail delivery service or unforeseen condition. A postmark on or before the due date WILL NOT be a substitute for receipt of bid. Bids received after the due date and time will be not be returned. Additional time will not be granted to any single bidder, however, additional time may be granted to all bidders when the City determines that circumstances require it. FAXED OR E-MAIL BIDS WILL NOT BE ACCEPTED.

Bonds

Each BID must be accompanied by a BID Bond payable to the OWNER for five percent of the total amount of the BID. As soon as the BID prices have been compared, the OWNER will return the BONDS of all except the three lowest responsible BIDDERS. When the Agreement is executed the bonds of the two remaining unsuccessful BIDDERS will be returned. The BID BOND of the successful BIDDER will be retained until the payment BOND and performance BOND have been executed and approved, after which it will be returned. A certified check may be used in lieu of a BID BOND.

A PERFORMANCE BOND and a PAYMENT BOND each in the amount of 100 percent of the CONTRACT PRICE, with a corporate surety approved by the OWNER, will be required for the faithful performance of the Contract.

Attorney in fact who sign BID BONDS, PAYMENT BONDS and PERFORMANCE BONDS must file with each BOND a certified and effective dated copy of their power of attorney.

Insurance Requirements:

- A. Statutory Workers Compensations Insurance **Employers Liability** Bodily Injury Accident - \$100,000 Each Accident Bodily Injury by Disease - \$500,000 Policy Limit Bodily Injury by Disease - \$100,000 Each Employee
- B. Comprehensive General Liability Insurance

\$500,000 Limit of Liability per Occurrence for bodily injury and property damage.

- C. Auto Liability Insurance \$500,000 Limit of liability per occurrence for bodily injury and property damage. Comprehensive form covering all owned, non-owned and hired vehicles
- D. Umbrella Liability Insurance-\$1,000,00 limit of liability

Envelope:

The signed bid should be submitted in an envelope or package, sealed and identified on the outside of the envelope with contact name, contact email, company name and due date.

Bid Opening: The bid packages will be opened and bid amounts recorded immediately after the deadline for submittal at Forest Park City Hall, 745 Forest Parkway, Forest Park, Georgia 30297. For all bids that clearly identify a primary contact, provide an email address for the primary contact, a list of the submitted bids with company name, and bid amount will be sent via email.

Selection:

All of the proposals are due on or before April 5, 2019 at 2:00 pm. Each proposal will be evaluated by the appropriate staff. Three (3) bidders will be placed on a "short list" and MAY be asked to come in for an interview. If so the bidders that are selected to come in for an interview may be asked to submit additional information. You will be notified within one (1) week prior to the interview date of any additional information that will be needed from our office. We reserve the right to ask for clarification or additional information contained so that a fair and comprehensive evaluation of all proposals can be conducted. If only 3 bids are received, the City reserves the right to terminate this process and begin again or to choose from the 3 submissions.

Debarment: Submission of a signed bid in response to this solicitation is certification that your firm (or any subcontractor) is not currently debarred, suspended, proposed for

debarment, declared ineligible or voluntarily excluded from participation in this transaction by any State or Federal department or agency. Submission is also agreement that the City will be notified of any change in this status.

Affidavit:

Bidder shall make an oath in writing that he/she has not engaged in any collusive or anti-competitive practices in the responding to the bid. Declaration of non-collusion is a statement that the bid submitted is a bona fid bid prepared independent of other bidders, without collusion or fraud (bid rigging, price fixing, rotation of award, etc.)

E-Verify:

E-Verify- All Vendors must submit an affidavit to certify that they participate in the Federal Employment Eligibility Verification. Participation in the E-Verify program must commence before the proposal deadline, and E-Verify affidavit is included in the package.

Proposal Form

Having carefully examined the request for proposal for the Outdoor Pool Renovation Project and having visited the site, examined and become familiar with all conditions affecting the cost of the work. The undersigned hereby propose to furnish all labor, material, equipment and incidentals as required; and to perform all work in the manner and form as provided. It is the responsibility of the bidder to furnish with their bid a list clarifying any and all deviations from these specifications, written or implied, in order that a fair and proper evaluation can be made. Those bidders not submitting a list of deviations will be presumed to have bid as specified.
